**CAMPAIGN REPORTING REQUIREMENTS**

**August 14, 2018** - Statement of Campaign Contributions report is due whether candidate is successful or not.

**August 31, 2018** - Statement of Campaign Contribution and Expenditures report is due whether candidate is successful or not.

**22-25-108. Failure of candidate or committee to file statement.** Candidates and committees shall be given notice prior to an election that failure to file, within the time required, full and complete itemized campaign forms shall subject them to civil penalties.

**August 6, 2018 is the last day to register to vote with the County Clerk for the Primary Election.** Voter Registration is permitted at the polls on the day of election.

**PROOF OF IDENTITY IS REQUIRED TO REGISTER TO VOTE.**

**ABSENTEE VOTING:** If a qualified elector is unable to be at the polls on Election Day, they may vote absentee. A qualified elector may request an Absentee Ballot by applying in person, in writing, or by phone. An absentee request form may also be downloaded from the County's website ([www.niobrara.org](http://www.niobrara.org)). Absentee Ballots **are not** available on Election Day.


